## Manager Report/Discussion

- Elise asked Pete about the viability of taking the issue of the district being able to borrow
  money to a vote of the people. Discussion ensued. This would be a stretch and a hard
  sell.
- Have come to a dead-end with looking for a lender that would loan funds to the District subject to the restrictions set out in our Service Plan.
- Meeting with Scott Trainor, his lawyer, finance director and preferred lender, to explore the possibility of having Fountain be the borrower, with an IGA between entities that commits us to making monthly loan payments, subject to annual appropriations.
- Gerry confirmed that Garret Richards has taken over as track operator for CC BMX.
   They have a full board of directors, have purchase some new equipment, and plan to be racing in March, weather depending.
- Directors discussed building the board strategically what experience would be most helpful to the development of the district right now? We have time to find a good person.
- Hale Reservoir signs have been installed. Park Rules & Regs will follow.
- A postcard has been designed, but only has room for the rules and regulations. Will also create a new brochure, which will have more room for positive messages as well as rules.
- Invasive Species plan is underway, as well as a Stormwater Management plan.
